### Primary Care Committee update - April 2018

<u>Improving Access</u>; the Primary Care Team continues to work closely with local primary care providers to establish plans for delivery of "Improved Access". In line with national requirements, the purpose of this initiative is to make available to patients, by 1 October 2018, additional general practice appointments in the early evening and also at weekends. It was reported that the Primary Care Team has planned two events to take place during April with practices, which will enable practices to hear about the key commissioning principles and hear from other stakeholders including a pilot site in Exeter.

<u>Online Consultation Software</u>; Committee received an update on the continued rollout of eConsult. The first tranche of practices is now well underway with 10 out of 16 now live. The second tranche of practices will start going live during April/May.

<u>Minor Improvement Grant 2017/18 final position</u>; Committee was pleased to receive an update reporting the final position of the Minor Improvement Grant programme for both Northern, Eastern and Western Devon CCG and South Devon and Torbay CCG for 2017/18. As a combined Sustainability and

Transformation Partnership (STP) area across Devon, it was noted that close to 99% of the allocated funding for minor improvements has been utilised by practices across both CCG areas.

<u>Winter Monies</u>; Committee received a summary of additional winter provision in general practice over the winter and Easter period. It was noted that financial allocations were announced for CCGs to fund additional primary care clinical capacity over the Christmas period to ensure anticipated demand was met and to ease demand in subsequent days. In South Devon and Torbay the money was split over three tranches; 22 December 2017 to 8 January 2018, 9 January 2018 to 5 February 2018 and over the Easter period from 27 March 2018 to 5 April 2018. Funding was allocated to localities, who were given a high degree of autonomy to use the funds as they felt appropriate, which worked well. Feedback received about the service provided has been very positive.

#### Social media workshop for PPGs and practices: Friday 27 April, Pomona House

In response to recent requests for advice, support and ideas with social media, we are providing a development workshop to help PPGs and practices review their approach to social media – primarily on Facebook and Twitter. The workshop will be able to address different stages of development:

- a) Complete beginners
- b) Aware of how things work, but need some tips to develop
- c) Doing it quite well but could do with extending reach and benefit to practice

The workshop will be at Pomona House on the morning of Friday 27 April. Practice staff responsible for developing social media, as well as PPG members, are welcome to attend. ### Stay Well This Winter campaign - did you see it?

From October 2017 to March 2018, the NHS in Devon and its partners ran a campaign to raise awareness of flu vaccinations and where people could get further help, treatment and advice for symptoms and illnesses during the cold winter months. This survey has been developed to see how successful the campaign was in attracting attention and raising awareness. ### Influence diabetic eye screening

Diabetic eye screening is an important part of diabetes care. People with diabetes are at risk of damage from diabetic retinopathy, a condition that can develop and lead to sight loss if not treated. Screening can identify retinopathy at an early stage and treatment can stop it from getting worse. Diabetic eye screening is offered to people with diabetes who are aged over 12 years.

NHS England will shortly begin a procurement process to secure future provision of Diabetic Eye Screening programmes across the South West.

To help with this process, NHS England and Public Health England wish to learn about the experiences of people with diabetes using Diabetic Eye Screening services across the South West. Service users' feedback will be used to develop services so that they best meet the needs of people with diabetes.

### **Devon Equality and Diversity: how well are we doing?**

#### Dates set to hear views on new health centre proposals

Dates for public drop-in events to talk about the possibility of creating a new health and care centre to support a wide range of health needs in Teignmouth have been announced. The NHS has said that a purpose-built building could be created to co-locate Teignmouth GPs with the multi-disciplinary health and wellbeing team, voluntary sector partners, and space being made available for outpatient clinics. The NHS is keen to hear the views of people in the Teignmouth, Dawlish and surrounding area, so a number of drop-in events have been arranged for the next six weeks, to enable people to ask questions or clarify any issues. Representatives from the South Devon and Torbay Clinical Commissioning Group (CCG), Torbay and South Devon NHS Foundation Trust and local GPs will be at the events.

If the new centre went ahead, it would be up and running before closure of the current Teignmouth Hospital took place, with services transferring across to the new building. The engagement will end on 8 June. People are asked to give their views by completing and returning the questionnaire before this date.

### Plymouth Hospitals NHS Trust name-change approved

Plymouth Hospitals NHS Trust has been given approval by the Department of Health to change its name to University Hospitals Plymouth NHS Trust, with effect from 1 April 2018. The new name better reflects its status as an organisation intrinsically involved with teaching, education and research. To minimise costs, the Trust will be changing its electronic logo and the main sign outside Derriford Hospital immediately, but other externally-facing literature and signage will be replaced as and when

current stocks are exhausted or other updates are required.

### **Devon Partnership Trust's chief executive among the best**

Melanie Walker, chief executive at Devon Partnership NHS Trust, has been recognised nationally as one of the top 50 NHS trust chief executives in the country. The *Health Service Journal's* fifth annual list recognises the NHS leaders who impressed the judges with their achievements in tough times. HSJ's annual ranking of all 249 trust chief executives is notable not only for women taking the top three places, but also for the rise of mental health chief executives.
